LEGAL NOTICE

In compliance with Regulation (EU) 2016/679 (General Data Protection Regulation – GDPR), the Polish Act of July 18, 2002 on the Provision of Electronic Services (Ustawa o świadczeniu usług drogą elektroniczną), the Spanish Law 34/2002, of July 11, on Information Society Services and Electronic Commerce (LSSI-CE), and in particular their respective information obligations, the following legal notice is made available to the user.

2. OBJECT

For the purposes of interpretation, a person becomes a User at the moment they accept this Legal Notice and the Privacy Policy published on the Website.

4. ACCESS AND REGISTRATION

By accessing and browsing the Website, the User accepts in its entirety and undertakes to comply fully with this Legal Notice, as well as the instructions or recommendations indicated in each specific case through the Website.

Access to the informational content of the Website is free of charge. Access to the Platform's transactional services requires registration and acceptance of the Terms and Conditions and Privacy Policy.

When a User provides personal data through any of the forms on the Website, prior acceptance of the Privacy Policy is required.

Under no circumstances shall Flusso be responsible for the veracity of the data provided by Users. Each User shall be solely responsible for the consequences, errors, and failures that may arise from the inaccuracy of the data provided.

5. INTELLECTUAL AND INDUSTRIAL PROPERTY RIGHTS

5.1. Content Rights

If any provision of this Legal Notice is declared invalid or unenforceable by any court or competent administrative body, such invalidity shall not affect the remaining provisions.

For the resolution of any dispute arising from or in connection with this Legal Notice, the parties submit to the exclusive jurisdiction of the competent courts of Katowice, Poland. Where the User qualifies as a consumer under applicable Polish, Spanish, or EU consumer protection legislation, the User may file a claim before the court competent under the applicable consumer protection rules of their habitual residence.
